### Prison Sentences for Child Abusers

3 December 2024

Catherine Pattison, leading Anna Dutka, prosecuted this case of causing or allowing serious physical injury to a child at Snaresbrook Crown Court. The case involved complex medical expert evidence and life-threatening injuries inflicted upon a 3-year-old child. Today the child's mother and her boyfriend were sentenced to over 10 years and over 11 years' imprisonment respectively.

### 28 years for man who killed sister-in-law with a hatchet

10 October 2023

Catherine Pattison and Sam Willis prosecuted this case of murder, which concluded this week with the court imposing on the defendant a life sentence with a 28-year minimum term. During a 3-week trial, the court heard how the defendant had brutally attacked his sister-in-law with a hatchet but claimed that he had been suffering from paranoid delusions that caused him to see her as a manifestation of the devil. The prosecution's case was that this 'sham defence' had been concocted by the defendant after his arrest to avoid the consequences of his actions. Earlier in the year a jury at the Central Criminal Court had rejected the defendant's account, convicting him of murder and making a threat to kill.

Catherine and Sam were instructed by CPS Homicide.

#### R v ST [Central Criminal Court] 2024

Teen Guilty of Neighbour's Murder

The defendant stabbed a man using a sword. The issue was self-defence. The defendant was convicted of murder.

#### R v JT & 3 Ors [Central Criminal Court] 2024

Four Jailed Over Machete Murder

A group armed with machetes stab two people outside Dagenham Heathway Underground Station. All four defendants were convicted of murder and attempted murder (and other offences)

### **R v TW & Anor [Snaresbrook Crown Court] 2024**

Two Guilty of Child Abuse

Two defendants pleaded guilty to causing or allowing a little boy (under 3 yrs) to suffer serious physical injuries, including: an intracranial injury; fractured jaw; multiple compression vertebral (backbone) fractures (chest level); laceration and swelling to the scalp; damage to the brain tissue; multiple bruises and lacerations.

### **R v TOK [Central Criminal Court] 2024**

Man Charged with Murder 5 Years After Stabbing

The defendant stabbed the victim in 2016. The victim survived but deprived of oxygen for such a period of time that he suffered catastrophic brain damage which left him in a vegetative state. The defendant was convicted of wounding with intent. The victim subsequently died resulting in the defendant being charged with murder. The key issue leading up to trial was causation. The defendant changed his plea to guilty.

### **R v DI & Anor [Kingston Crown Court] 2024**

Fatal Stabbing Over A Box of Beer

The defendants targeted males who had just bought a box of beer. An argument and fight ensued. Ivanov fatally stabbed one of the males and injured another. Ivanov had consumed an excessive quantity of alcohol and said that he could not remember the events and suffered blackouts. He was convicted of murder, wounding with intent and

having an offensive weapon. One other defendant was convicted of manslaughter, ABH and having an offensive weapon.

### **R v OO, IE & BE [Central Criminal Court] 2023**

Organ Harvesting Plot

This was the first prosecution of trafficking for the purpose of organ harvesting in English legal history.

### **R v NV [Central Criminal Court] 2023**

28 Years for Man who Killed Sister-In-Law

The defendant murdered his sister-in-law. The defence advanced at trial was diminished responsibility. This was rejected by the jury. The defendant was convicted of murder and making a threat to kill.

### **R v SS & JS [Central Criminal Court] 2023**

Couple Convicted of Murder after Forced Confession

The defendants were partners at the relevant time. They were convicted of the murder of SS's stepfather and

preventing the lawful and decent burial of his body. SS ultimately admitted to an undercover police officer that she and JS had murdered her stepfather. They were both convicted.

### **R v DM & Ors [Central Criminal Court] 2023**

Five Found Guilty of Murder following Robbery

The defendants broke through the front door of a known home address looking for a substantial quantity of drugs, They were armed with several bladed weapons. One of the occupants tried to resist but was fatally stabbed in front of two friends. DM was convicted of murder and four others were convicted of manslaughter.
