Practice Profile

Robert Ellison is a Criminal and Regulatory barrister renowned for his expertise in cases of Serious Fraud, Homicide, Organised Crime and Police Misconduct.

Robert Ellison is frequently instructed as a Leading Junior in complex and demanding cases. He prosecutes and defends across the whole range of criminal offences. In recent years his work has focused on cases

involving Organised Crime Networks, Serious Fraud and Regulatory work. He is described as “*adept at strategy and a skilful advocate who is liked by juries.*”

He has developed particular expertise in cases involving complex Fraud, Police Misconduct, Public Interest Immunity issues and challenging Forensic evidence. Unusual areas of his work have included HIV Transmission cases, Police Pension Forfeiture and Security Vetting Appeals. He also handles Company Director Disqualifications and Judicial Review.

The combination of his background and academic ability often enable him to bring useful insights to difficult cases. He served with the Metropolitan Police from 1981 to 1995. He left the service as a Detective Sergeant with particular experience of covert police operations and Homicide investigations. He was an outstanding legal scholar who received academic awards for his achievements at the University of London and the Inns of Court School of Law.

He has a keen interest in the Financial Markets and offers expertise in FCA regulated activities and trading frauds. His current cases include tax fraud using capital loss relief, ‘boiler room’ fraud, and Police Misconduct hearings.

Operation Lunar [Birmingham] 2017

£Multi-Million HMRC Tax Avoidance Prosecution

[Sarah Forshaw QC](#) and [Robert Ellison](#) acted in the defence of this defendant charged with 10 others of a multi-million pound conspiracy to cheat HMRC. The fraud centred around multiple tax avoidance schemes. The charges were dismissed against our client following legal argument. The trial on the remaining defendants is listed for 6 months in 2019. Police Misconduct

[Robert Ellison](#) defended an officer in this Thames Valley police misconduct case. Issues included breach of confidentiality and Data Protection regulation. Co-defending with Queen's Counsel, his client was cleared of any wrongdoing. Instructed by Cartwright King.

Child Cruelty

[Robert Ellison](#) successfully prosecuted this child cruelty case involving the sadistic torture of an infant. Issues included the admissibility of psychological evidence about the mother of the child.

Supply of Firearms & Ammunition

[Robert Ellison](#) led [Dickon Reid](#) in this case involving four defendants charged with possession of a firearm with intent to endanger life, possession of cannabis with intent to supply and with the supply of firearms and ammunition. The defendants were accused of robbing drug dealers at gunpoint of cash and drugs.

DWP Fraud

HIV Transmission case

[Robert Ellison](#) defended in an HIV Transmission case with multiple victims. Issues included legal argument on the extent of 'knowledge' required before a complainant could be said to be 'consenting' to the risk of infection

- **R v. Iqbal & 18 ors [Southwark] 2014**

Banking & Credit Fraud

[Robert Ellison](#) led [Jonathan Polnay](#) for the Prosecution in this 19 defendant Credit and banking fraud with many thousands of pages of served and unused evidence. A conspiracy to defraud creditors and 'Acquiring Companies' by abusing technical weaknesses in the 'chip and PIN' payment process. The fraud was so complex that the trial judge described the methodology and money laundering as an 'impenetrable scheme'.

- **R v. Cisse & 5 ors [Croydon] 2014**

Conspiracies to commit armed robberies

[Robert Ellison](#) acted as leading junior. A conspiracy to commit armed robberies. Issues included complex circumstantial evidence based upon telephone data and data from vehicle security tracking systems.

- **R v. Kendrick [Luton] 2014**

Rape

[Robert Ellison](#) defended in this Rape of a 12 year old girl. The case required a lengthy cross-examination of the young complainant who had learning difficulties.

Thames Valley Police v. S & ors [Disciplinary Tribunal] 2010

Police Misconduct

[Robert Ellison](#) represented an officer in Police misconduct proceedings at a 2 week discipline hearing involving four officers charged with breaches of the Discipline Code involving Dishonesty and bringing the service into disrepute. The allegations were that officers were taking and supplying Class 'A' drugs. The officer was cleared of all charges.

Boiler Room Fraud

[Robert Ellison](#) defended in this "Boiler Room" high pressure, share-pushing operation from call centres in Spain. Around 1,250 investors in the UK were persuaded to buy over £7 million worth of shares. Using their "Gordon Gekko" contract notes to complete the transactions. POCA proceedings involved assets totalling £4.5m.
